- Booth space is limited to an area of 10' x 10'.
- Food trucks: please list the ground space needed for your vehicle here: _____ ft. x _____ ft.
- One booth space is allowed per application/fee. Additional booths will require an additional application/fee.
- Booth location is pre-assigned. We will try our best to accommodate any special requests.
- Participants are responsible for providing their own tents, tables and chairs.
- You will receive an email regarding schedule for check-in. Unloading & parking instructions.
- All tents **MUST BE STAKED DOWN**
- No vehicles will be allowed in vendor booth area after unloading time. All vehicles (excluding food trucks) will be required to park in the general parking area. No exceptions.
- Booths must be available for the duration of the event, 7:00am – 12:00pm. You will not be allowed to break down before 12:00pm.
- If you require electricity, we will NOT be able to provide access to electricity on site, so please bring your own generator. Quiet generators are requested. Thank you for your cooperation and understanding.
- All vendors are encouraged to use “green practices” such as biodegradable bags, etc.
- No pets are allowed.
